Competition Categories

Age Requirement

Students must be within the age ranges listed for all AEROSkools events. The age is determined by how old the student will be as at the 31 December in the year of competition.

Senior Division	(age 14 – 18)

Note: Students may compete in more than one category (trio and/or group) per competition, but not more than once in one category.

Students can only compete in one Level (Level 1, Level 2 or Level 3) per category and per competition and cannot compete in a lower Level after their first AEROSkools competition. For example: a student forms part of a Trio in the Intermediate Division Level 2. The student cannot compete as a member of a Group in the Intermediate Level 1. Having competed in the Level 2 division that student can only remain in Level 2 or move through to Level 3. The student cannot compete in Level 1.

COMPETITION SCHEDULE

Competition Timetable:

The 2008 AEROSkools State Championships will be conducted over one day. There will be one round of competition.

Sunday 29 June 2008

From this event a State Team will be selected. Selection will be a judged on merit of the team's performance. The winners of the event do not gain automatic selection. It will up to the selectors discretion as to whether the teams are at a national standard. More than one team per age group may be selected.

GYMNASTICS AUSTRALIA'S PRIVACY STATEMENT

Students entering an AEROSkools event will automatically become members of Gymnastics Australia. All event entry information including student names and addresses will be recorded on the Gymnastics Australia's database.

Gymnastics Australia has a strict privacy policy that prohibits the use of the membership database for non-gymnastics purposes.

PRIVACY STATEMENT

Gymnastics Australia is committed to providing you with the highest levels of membership service. This includes protecting your privacy. From 21st December 2001, we will be bound by the new sections of the Commonwealth Privacy Act 1988, which sets out a number of principles concerning the protection of individual's personal information.

The aim of these new laws is to ensure that organisations handle personal information responsibly and provide a consistent approach to its collection, use and disclosure. These new laws also give the individual new rights such as access to their personal information and the ability to correct it, if needed.

Our Privacy Statement contains the following important information the Privacy Act requires us to communicate to all of our customers, regarding the use of your personal information.

- When we disclose personal information
- Storage and security of personal information

What is personal information?

Personal information is information about an individual who can be identified, or whose identity could be reasonably ascertained, from the information.

How we collected personal information

To deliver and enhance the services offered by Gymnastics Australia, certain personal information is collected. Gymnastics Australia collects personal information from you that you volunteer when:

- You register to become an affiliate club
- You register to become an affiliate gymnast
- You register to become an affiliate technical member
- You enter a Gymnastics Australia event or participation program
- You participate in a Gymnastics Australia course
- You purchase merchandise from us
- You request information from us
- You provide information to one of our staff
- You participated in one of our surveys

How we use personal information

We will only collect information that is necessary for us to carry out our primary purpose of providing services relating to: membership, education, events and merchandise.

Your personal information may be used in order to:

- Provide the services you require
- Internal accounting and administration
- Regulatory reporting and compliance

- Helping us to identify and inform you about other products or services that may be of benefit to you.

If we send you any information about services or products you do not require, or you do not want us to disclose personal information to any other organisation (including related organisations) you can advise us accordingly by writing to our Membership Officer. If you do not advise us otherwise, you confirm agreement on your own behalf and/or on behalf of others we represent.

If you choose not to provide personal information, we may not be able to provide you with the services you require or the level of service on which we pride ourselves.

When we disclose personal information

We disclose personal information to other organisations that we believe is necessary to assist in providing our services. The organisations to which we disclose information include:

- Outsourced service providers who manage the services we provide to you, including:
- Insurers
- Sport Education Section (ASC)
- Our professional advisors, including our accountants, auditors and lawyers
- Government and regulatory authorities and other organisations, as required or authorised by law

We limit the use and disclosure of any personal information provided by us to such organisations for the specific purpose for which we supplied it.

When you provide us with personal information about other individuals, we rely on you to have made them aware that you will or may provide their information to us, the purposes we use it for, the types of third parties we disclose it to and how they can access it. This is extremely important for club owners providing the personal information of their members.

Storage and security of personal information

Gymnastics Australia stores personal information on a computer database. Your personal information may be held in both paper file and computer file form. We have implemented measures of a reasonable nature to ensure that all personal information about you is securely stored from misuse, loss and unauthorised handling.

Accuracy of personal information

We take reasonable steps to ensure that whenever we collect, use or disclose personal information that it is accurate, complete and up to date.

Access to personal information

You have a right to access your personal information, subject to some exceptions allowed by law. If you would like to do so, you can gain access to your personal information by contacting our Membership Officer or by writing to Gymnastics Australia. Alternatively, you may also advise us at any time about possible breaches of privacy or inaccurate, incomplete personal information that may have changed.

I hereby assume all risks of participating and/or volunteering in this event. Further, I agree to examine the physical staging area of the competition for any possible defects (e.g. wet or oily surface, cracks, etc) and, without limiting the generality of the foregoing, waive any and all claims relating to the physical staging area of the competition. I realise that liability may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained or controlled by them or because of their possible liability without fault.

I certify that I am physically fit, have sufficiently trained for participation in the event and have not been advised otherwise by a qualified medical person.

I acknowledge that this Accident Waiver and Release of Liability form will be used by the event holders, sponsors and organisers, in which I may participate and that it will govern my actions and responsibilities at said events.

In consideration of my application and permitting me to participate in this event, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (A) Waive, Release and Discharge from any and all liability for my death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter accrue to me including my travelling to and from this event, THE FOLLOWING ENTITIES OR PERSONS: Gymnastics Australia, AEROSkools Participation Program, the Producers and Sponsors of the competition and its related activities, all agents, employees, venues and licensees of the foregoing, their directors, officers, employees, volunteers, representatives, and agents, the event holders, event sponsors, event directors, event volunteers; (B) Indemnify and Hold Harmless the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in this event, whether caused by the negligence of releases or otherwise.
